## 1921 Legacy Society

*What if there was no safe place for animals in Washington County?*

*What if we were forced to pick and choose which animals we could help, or even worse....what if we were forced to turn them away before they even made it in the door?*

### Our Journey

The Humane Society of Washington County (HSWC) began in November 1921 with Ms. Daisy Derby Whipple and 12 animals in a one-room building on South Boulevard (now Wilson Boulevard). In April 1938, the HSWC moved to its current location on Maugansville Road and operated from a trailer. The organization grew and eventually built the existing 13,200 square foot animal shelter in December 2001.

By 2015, we had transformed HSWC into a life-saving animal shelter. In June of that year, we unveiled a newly constructed 6,800 square foot state-of-the-art veterinary center and adoption lobby with a pet supply store and cage-free housing for cats.

Today, HSWC employs more than 40 staff and 250 volunteers who provide compassionate, skilled care to over 6,000 animals annually. What started in a one-room building in 1921 has grown into a progressive animal welfare organization that offers a wide range of services to the community.

### Your Legacy Society

We share Dottie's belief for cats and for all animals. And that is why we think her wish to establish a Legacy Society is the perfect way to make a long-lasting, lifesaving difference.
